Therefore, it is crucial to obtain a license showing proficiency of installation and compliance with the code.

An unlicensed, untrained person performing residential plumbing, HVAC or electrical work can blow up, burn down, flood or cause a cross connection that can put themselves and the community they live in at risk of sickness, disease, and potential criminal and civil proceedings against them.

These are some of the other professions that are now licensed in the State of Ohio: Accountants, Auctioneers, Chiropractors, Cosmetology Services, Insurance Agents, Realtors, Doctors, Nurses, Teachers, Attorneys, Barbers, Beauticians, Appraisers, Architects and Engineers.
