Legislative Update Progress continues on our licensing bill, HB 339, following our interested parties meeting in February. The main focus from opponents is on new residential construction and definitions regarding "employee." ACCO and PHCC Ohio have created (and sent to parties) language for the bill. We feel the language takes care of the issues and will result in moving the bill forward.

Other than HB 339, the following licensure bills have been introduced:

HB 148 License Home Improvement Contractors

HB 164 License Roofers

HB 71 License Home Inspectors

HB 236 License Elevator Contractors

HB 504 License Interior Designers

SB 115 License Roofers, Gutter and Downspout Contractors

IRS Releases Fringe Benefit Guidance by Chuck White, PHCC VP of Regulatory Affairs the Dept. of the Treasury has released a tax guidance document to help employers and employees understand the tax reform act's changes to fringe benefits. Included are details such as mileage reimbursement being changed to 54.5 cents per mile, changes to "Cafeteria Plans," limitations on Sub-chapter S shareholders, personal use of vehicles and cell phones, and other common fringe benefits.
